## ► BACKGROUND:

Syrian NGOs (SNGOs) were established in response to the need for humanitarian assistance inside Syria and also meet the needs of Refugees in neighboring countries post March 2011. Some SNGOs felt the need for a body where common advocacy messages relating to humanitarian issues are being agreed. Syrian NGO Alliance (SNA) saw the light on the 2nd April 2014 in Gaziantep, Turkey.

## ► WHO ARE WE?

SNA consists of **22 SNGOs** who are some of the largest SNGOs working to meet the Humanitarian needs in line with international standards and protocols. SNA provides the umbrella for these SNGOs to coordinate and advocate common messages ensuring the voices of affected populations heard. 

## **► SYRIAN NGO ALLIANCE (SNA) ADVOCACY ACTIVITIES:**

**From 3–1 December**, the conference “Syrian Humanitarian Action & Recovery Conference Local solutions for lasting impact” was held in Damascus, bringing together more than 150 representatives from Syrian civil society, the Syrian government, international partners, and international non-governmental organizations. The conference included a keynote address delivered on behalf of civil society by the Coordinator of the Syria NGO Alliance (SNA).

The conference opened with a session titled “Challenges and Expectations of Syrian Non-Governmental Organizations,” which presented the findings of a survey involving more than 150 local organizations, followed by a high-level session on “The Role of Civil Society in Humanitarian Action and Recovery in Syria.” On the second day, participants took part in four rounds of parallel practical workshops held across three rooms, focusing on key thematic areas. Discussions highlighted structural gaps in partnership frameworks and local leadership, including the absence of a national localization framework, weak coordination, and unclear roles between donors and organizations, alongside the continued perception of Syrian organizations primarily as implementers and the lack of standardized capacity assessment tools.

Workshops also addressed challenges related to financing and resource mobilization, emphasizing funding fragility, financial restrictions, and complex banking procedures, while proposing solutions such as diversifying funding sources, adopting long-term institutional funding, improving data quality for needs assessment, and establishing locally led pooled funding mechanisms to enable direct access to resources. In addition, participants underscored the importance of strengthening community engagement and empowerment through meaningful participation in policy-making, planning, implementation, and monitoring to ensure the quality and sustainability of interventions. Capacity building and knowledge sharing were also central themes, with a focus on comprehensive approaches that go beyond technical skills to include good governance, strategic planning, knowledge management, contextual analysis, conflict sensitivity, and digital transformation, supported by robust monitoring and evaluation systems that measure impact rather than outputs alone.

The conference concluded with the adoption of a joint civil society statement outlining a clear vision for localization and strengthened local leadership. The statement emphasizes community empowerment, equitable and transparent partnerships, sustainable financing, and effective local governance, and presents targeted recommendations for the Syrian government, donors, and local organizations to support a sustainable, locally led humanitarian and recovery response.

**On 4 December**, the Syria NGO Alliance (SNA) convened the second session of its financial workshop for member organizations. The session continued discussions on the financial and banking challenges facing member organizations, with a focus on harmonizing accounting systems and managing financial records, as well as ensuring financial compliance with donor and regulatory requirements. Participants also reviewed mechanisms for handling domestic and international transfers, grant management and financial reporting, tax procedures, and staff registration processes, in addition to emphasizing the importance of appointing certified accountants to enhance transparency and reduce financial risks. The session highlighted the role of internal financial committees within each organization in overseeing grant implementation and internal reporting, streamlining procedures, and ensuring efficient financial operations, while reaffirming the importance of continued coordination among alliance members to strengthen financial sustainability and effectiveness across all projects.


